RESERVATIONS

A 50% deposit per person to secure space on a first come, first serve basis, with a remaining balance of 50% due on or before January 10th, 2025

The total cost for our “Surf & Yoga Retreat, Lobitos, Peru” (the retreat) is \$2,450 for private occupancy accommodations, and \$2,300 for shared accommodation.

An Early Bird Discount of 10% is available if Payment in full is received by December 25, 2024.

LATE REGISTRATION

Participants may register after March 2nd, 2025 space permitting, however payment in full is required at time of registration.

Changes in the itinerary will not incur extra charges to the participants or result in a refund for any portion of the retreat price.

CANCELLATION POLICY

All requests for cancellation must be submitted in writing to the retreat organizers at LA ONZA to laonza.lobitos@gmail.com and received by the dates listed below.

Regardless of the reason, cancellations result in additional costs and processing time for the retreat organizers, as such all cancellations are subject to a \$50 cancellation fee.

MORE THAN 60 DAYS PRIOR TO START DATE: (Up until Jan 27th)
\$50 Cancellation Fee, plus 80% deposit refunded

59 - 45 DAYS PRIOR TO START DATE: (Jan 27th-Feb 12th)
\$50 Cancellation fee, plus 50% deposit forfeited

LESS THAN 45 DAYS PRIOR TO START DATE (After Feb 12th)
\$50 Cancellation fee, plus full balance forfeited

If the participant leaves the retreat for any reason prior to its conclusion, refunds will not be made for the unused portion of the retreat.

No refunds will be made for any excursion, meal, yoga class, workshop, or other activity that the participant misses or decides not to participate in for any reason.

The retreat is subject to a minimum enrollment of 7 participants and a maximum of 16 participants. The retreat organizers reserve the right to cancel the retreat prior to departure. If such a cancellation is NOT due to circumstances beyond the retreat organizers control, such as war etc, as set forth below, the retreat organizer will refund all payments, constituting full settlement with the participant. No compensation will be made when cancellation arises before or during the trip from circumstances beyond our control (force majeure) such as war, strife, civil disobedience, strikes, terrorist activity, adverse weather conditions, fire, natural disasters, etc., unless or until the retreat organizer is able to recover any retreat related sums. In the event of

cancellation arising from circumstances beyond our control, as set forth above, retreat related sums recovered by the retreat organizer will be distributed equitably to the participants after the retreat organizer deducts all out of pocket costs and related expenses.

It is highly recommended that participants purchase their own trip insurance. The trip organizer is not responsible for expenses, including but not limited to, lodging, meals and transportation incurred for delays and/or detentions beyond the trip itinerary as a result of circumstances beyond our control such as war, etc., as set forth above.

NATURE OF THE RETREAT

This is a surf & yoga vacation for anyone age 18 and older. Accordingly, participants are strongly encouraged to fully attend all of the offerings provided. All participants are encouraged to approach the Retreat with a spirit of oneness, adventure and self-discovery.

PASSPORT AND VISA

A passport must be obtained in advance. Each participant is responsible for determining their specific passport requirements and for obtaining the necessary documents prior to departure. If you already have a passport double check the expiration date and be sure it is not set to expire within 6 months prior to the retreat date. If so, renew it as soon as possible. The renewal process can take some time. A Visa is NOT required for Peru.

MEDICAL INSURANCE

For your own safety, well being and financial protection, it is essential that you are adequately insured. Each participant is responsible for checking with their current health insurance provider and ensuring that they have adequate medical coverage. Participants must carry insurance documentation while on the retreat.

MEDICAL PROBLEMS/DISABILITIES

If you have a medical condition or disability which may affect your participation, you must inform us before confirming your booking so that we can advise as to the suitability of the chosen retreat. You must also provide us with full details in writing at the time of booking and notify us of any changes or deterioration in the disability or medical condition or development of any disability or medical condition after booking.

We reserve the right to decline any booking or cancel (in the event of the development, deterioration or change of any disability or medical condition occurring after confirmation) whenever we reasonably feel unable to accommodate the needs of any particular participant or we feel that the participant could be in danger.

TRAVEL INSURANCE

Although optional, it is highly recommended that you purchase travel insurance. Travel Insurance is usually offered by your airline when booking flights or can be purchased through many other agencies, including AAA or Travel Guard. This insurance should cover trip cancellation/interruption, lost luggage, delays etc.

PHOTOGRAPHIC RELEASE

As a participant of any LA ONZA Experiences, you permit the retreat organizers to use photographs or video from the retreat in advertising or publicity materials without any further consent.

RELEASE/RESPONSIBILITY - WAIVER OF LIABILITY

The participant, by signing this Retreat Participant Agreement, agrees that the retreat organizers and it's representatives, shall not be held liable for any injury, damage, loss, delay, or irregularity that may be occasioned for any reason, including but not limited to any defect in a vehicle, the acts or default of any company or person engaged in conveying a participant, acts of God, terrorism, acts of war, or detention; delays or expenses arising from quarantine, strikes, thefts, pilferage, force majeure, civil disturbances, government restrictions or regulations, accidents by aircraft, boat, bicycle, or motor vehicle, or in any restaurant or accommodation; failure of any means of transportation to arrive or depart as scheduled or changes in transit, missed airline or other transportation connections; or for additional expenses resulting from changes in exchange rates, tariffs or itinerary.

The participant agrees to assume all risks associated with the retreat and agrees that no liability will attach to the retreat organizers, it's employees or agents, or to any member of of the trip in respect of death, personal injury, illness or delay of the passenger, or for any loss of or damage to the property (including luggage) of the participant during the course of the trip, howsoever caused.

By signing this Retreat Participant Agreement, the participant releases the retreat organizers and its representatives from any such responsibility or liability. It is highly suggested that participants purchase travel insurance that covers cancellation, property damage (including luggage) and accidents.

For the benefit of everyone on your retreat, the retreat organizer reserves the right to accept or reject any retreat participant at any time without liability, and in the event it determines, in its sole and exclusive discretion, that a participant is disruptive to the harmony of the retreat it may without any obligation to pay a refund or any other amount whatsoever, expel such a participant from the retreat. The retreat organizers will have no responsibility or liability for any participant who leaves the retreat prior to its conclusion or for any activity undertaken by any participant which is not included in the trip itinerary.
